

The LA County Department of Arts and Culture utilizes SurveyMonkey Apply (SMAppl), an online grant management system, to provide a streamlined and user-friendly experience for applicants and reviewers. Applications are reviewed and scored entirely online without the need to print forms and make handwritten notes. Utilizing SMAppl, panelists can review and score applications anywhere there is internet access.

Accessing the Panelist Account



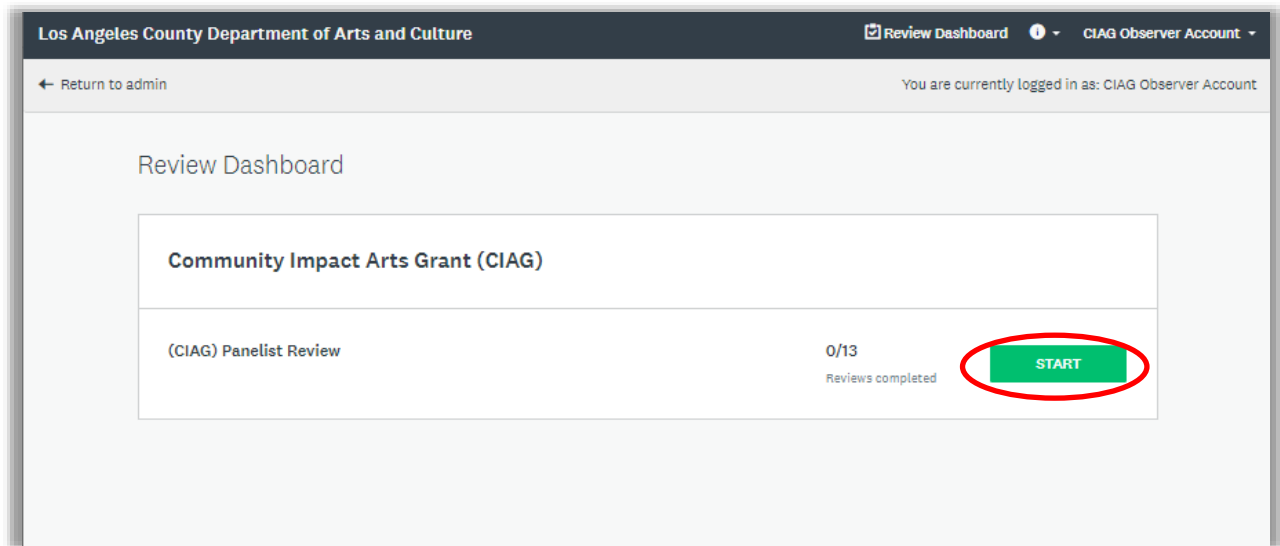

Once you've logged into the system, you will be directed to a landing page called, "Review Dashboard."

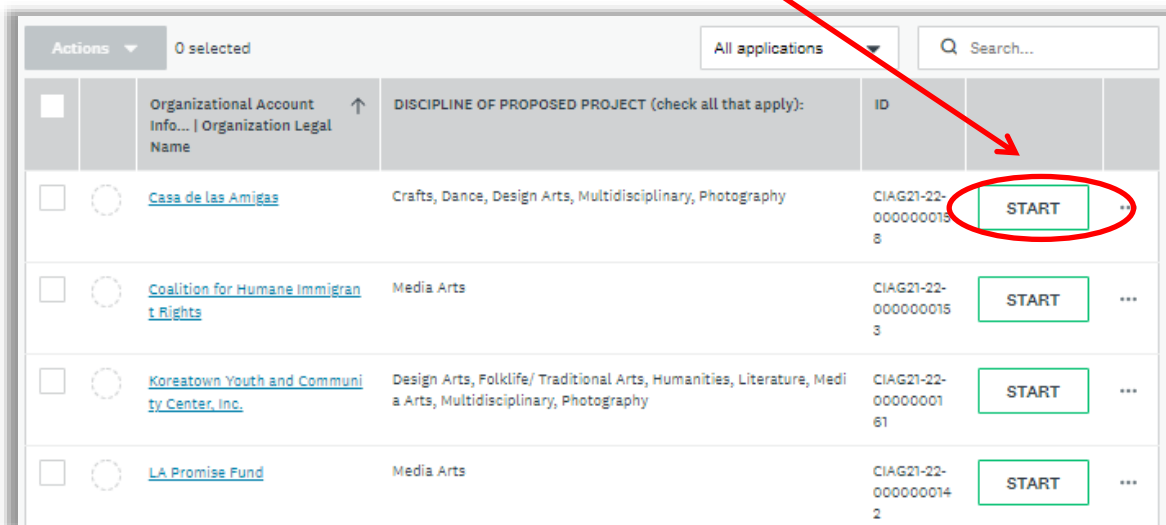
Navigating the Review Dashboard

The review dashboard organizes CIAG applications for your assigned panel. In order to view the applications, you've been assigned, click the green "Start" button. Please reference the Applicant Rosters, which lists the applicants in the order panel in which they will be reviewed.



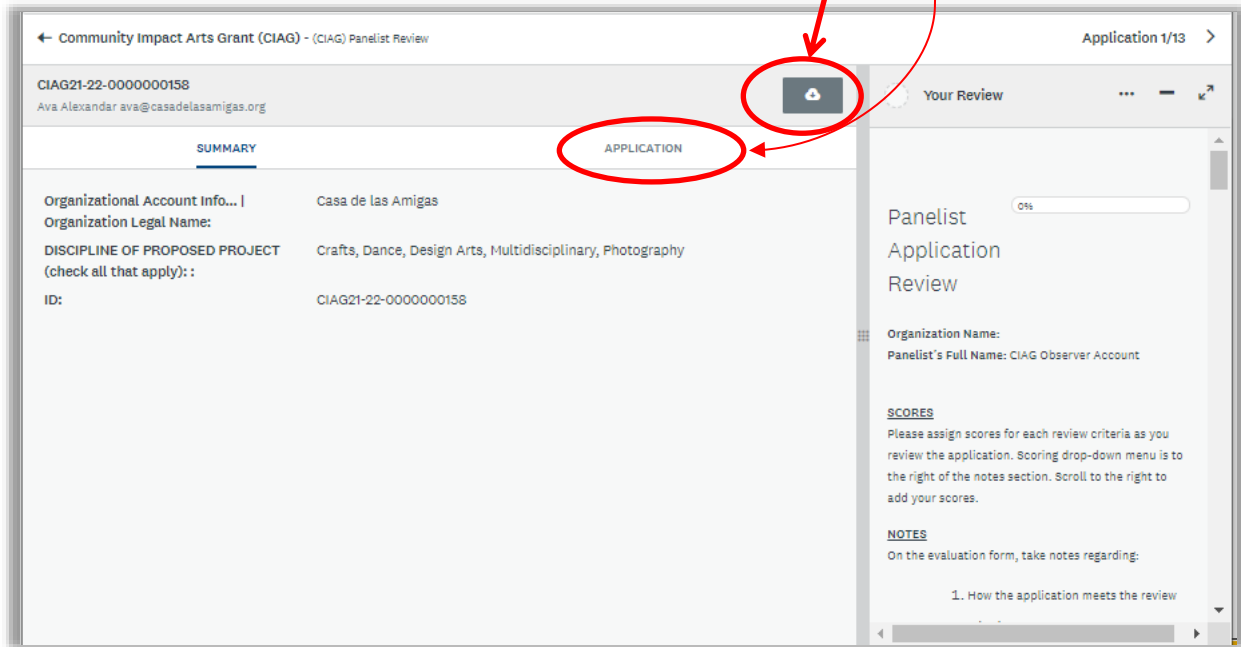
Reviewing the Applications

To review the applications, click on the "START" button to open the review and application split-screen. You will only see the applications you have been assigned. Only review the applications included in your Applicant Roster.



Once you click on the “START” button, you will be redirected to the page below. Next, click “Application” to review the application details.

You can also opt to download the application in its entirety by clicking the download button.

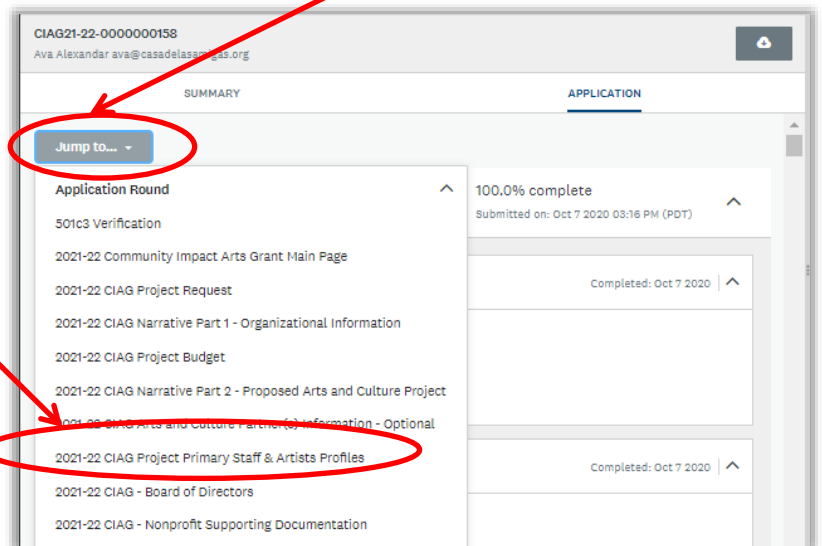


Once in applications, you will have the option of accessing specific applications sections using the “Jump to” option.

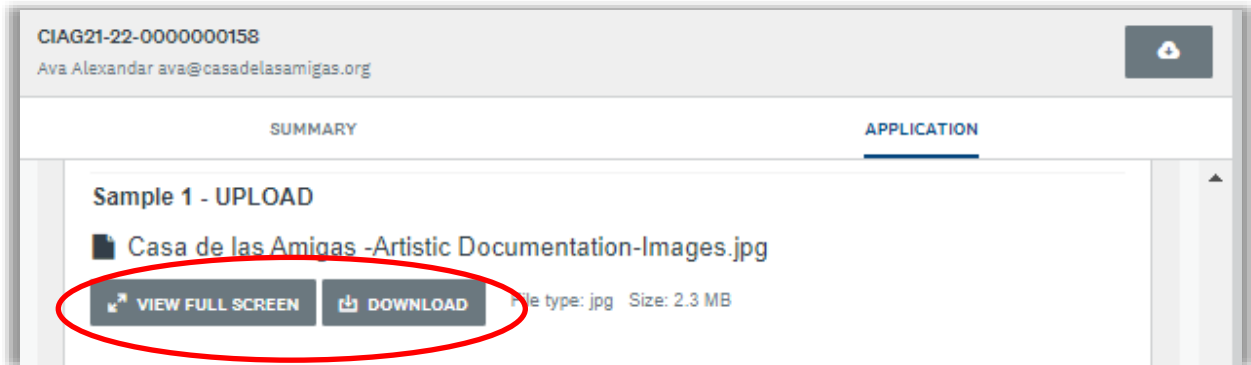
Accessing Artistic Samples & Support Materials

All application materials can be viewed by selecting the Supporting Documentation section of the application. Depending on the type of applicant, this section will have a prefix of either “Nonprofit,” “Fiscal Sponsors” or “Municipality.”

In the example shown at right, select “2021-22 Nonprofit Supporting Documentation” to view the artistic samples.

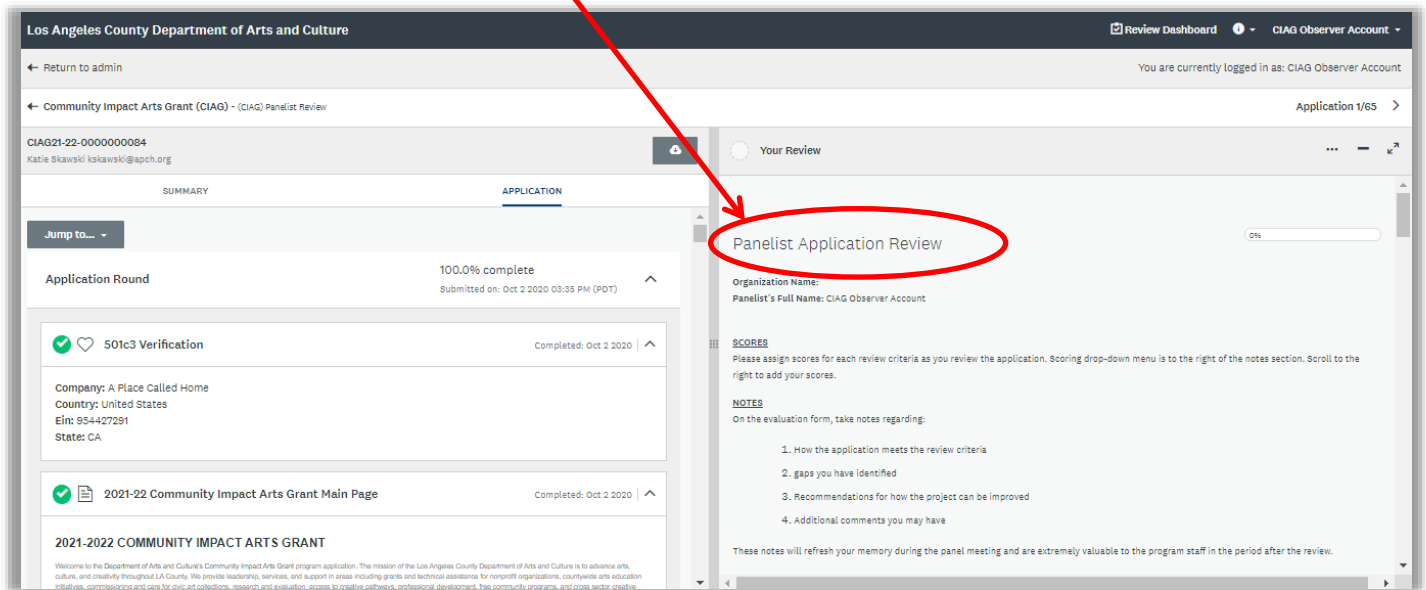


In the Supporting Documentation section of the application, you can opt to either view the video in a full screen pop-up screen or download.



Panelist Application Review

Below is the application review split-screen. Using the scroll, you can see all five (5) review criterion.



Below is the review pane where your notes and scores will be entered. Once all scores and notes have been entered, click the “Save & Continue” button.

Clicking “Save & Continue” will take you to the page 2 where you will see your overall score for the applicant you have reviewed. Scores are calculated out of 100. If the score is low, please check that all five criterion have been scored.

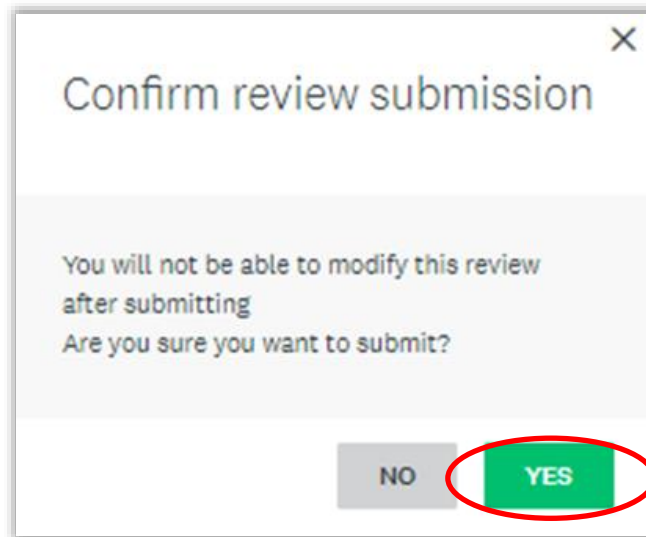

This will allow you to review and amend scores during panel discussion, if desired.

If you click “MARK AS COMPLETE” the following window will appear.
