**7.1 Strategic Planning for the LA City/County Native American Indian Commission**

Chair Imitates Dog opened the Strategic Planning session by inviting commissioners to share how they are feeling in light of the new Trump Administration. The Commissioners had a lengthy discussion, sharing how the first few days of the new administration was impacting them personally and professionally as well as concerns and thoughts they had on how it has and will continue to impact the Native American Community in Los Angeles County and throughout the country. The Commission also discussed possible ways that the body could support the community in this unprecedented time.

Alexandra Valdes (ED) shared that Chair Imitates Dog and her had spoken about the possibility of shifting the February LANAIC meeting into an opportunity to hear back from the AIAN community regarding the catastrophic fires and the recent Executive Orders and policy changes at the Federal level. The Commission expressed enthusiasm for this idea and decided to proceed with coordinating a listening session.

*A non-working lunch break was taken between 12:00 P.M. and 12:46 P.M.*

Following lunch Chair Imitates Dog led the Commission through an exercise to flush out the newly adopted FY24-25 workplan through the end of 2025 as well as to add to the workplan a February Community Listening Session. The body discussed and planned out all aspects of the listening session including, the format, roles and small group questions.
