Presentation

**7.1 Christopher Columbus Statue Loan to the Craft Contemporary – Lalena Vellanoweth, LA County Department of Arts and Culture - Conservation & Collections Manager, Civic Art Division & Frida Cano, Craft Contemporary - Senior Curator**

Lalena Vellanoweth, Conservation & Collections Manager at the Department of Arts and Culture, provided a brief update about a recent request the County received from the Craft Contemporary to borrow the County’s Christopher Columbus Statue that has been stored at Carnevale & Lohr since its removal from Grand Park in 2018. Craft Contemporary Senior Curator Ms. Frida Cano then presented the museum’s proposal to borrow the Christopher Columbus Statue for an upcoming exhibit titled *Vandalismo Artesanal* by artist Carlos Castro Arias.

The commissioners engaged in a discussion regarding the request. While it was expressed by some commissioners that they appreciated the thoughtfulness of Frida's presentation, they had numerous questions for her and shared several concerns with the requested loan and overall expressed a desire for the County to not loan the statue for this exhibit. Because of the risks, possible harm, and unintended consequences associated with this exhibition, the LANAIC overall felt there was no reason that the County should be involved.

The following questions and concerns were shared:

- How would the Craft engage with Gabrieleno tribes and people for this exhibit?
- How would the truth of Columbus be provided in this exhibit?

- Removing this statue from storage and putting it back in public view would anger and upset members of Native and Indigenous communities, including those who advocated for its removal and spent time providing public comment.
- Any accountability for backlash or negative response would fall on the LANAIC for supporting this loan and exhibition.
- The Commission would rather support an exhibit that uplifted and celebrated Indigenous leaders that the general public has little to no awareness of.
- Within Native cultures, when someone is banished, they are not welcomed back.
- While the artist's intent was understood, the adornment in Indigenous beadwork felt that it beautified and venerated Columbus.
- There was also a concern regarding this exhibit coinciding with the political environment we are in, and that right now is very fraught and could elicit extremely strong responses from both sides of the political spectrum.
- The timing of the exhibit starting in Native American Heritage Month was also flagged as a concern.

## **Process of Selecting Native American Heritage Month Honorees**

The Los Angeles City/County Native American Indian Commission (LANAIC) selects three individuals or organizations to honor during Native American Heritage Month (NAHM) and recommends that the LA City Council and the County of Los Angeles Board of Supervisors also honor them. This year's NAHM honorees will be selected at the Tuesday, August 18, 2026, LANAIC meeting. Nominations must be submitted via email to Alexandra Valdes (aferguson@lanaic.lacounty.gov) by Tuesday, August 11, 2026, by 5:00 PM. Nominations received after this time will not be considered.

Commissioners can submit up to 1 nominee per honoree category and are asked to submit a brief biography of the individual or organization (no more than 250 words) and a brief statement explaining why they should be considered a 2026 honoree for their respective category (no more than 250 words). Please ensure you submit both a bio and statement on the individual/organization so that fellow commissioners have information on all honorees when making their selections.
